Is the Constitution Alive and Well?

The short form answer to this question is NO!
The long form answer will come later.

The Constitution of the United States is the document that makes us a separate sovereign nation. This document would never have existed if the Declaration of Independence had not been signed by 56 courageous men who were delegates to the Continental Congress in Philadelphia. As we all know but cannot possibly fully cognize, these men declared and pledged these words in the closing paragraph:

We, therefore, the Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by the Authority of the good People of these Colonies, solemnly publish and declare, That these United Colonies are, and of Right ought to be Free and Independent States; that they are Absolved from all Allegiance to the British Crown, and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that as Free and Independent States, they have full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. And for the support of this Declaration,

At the time I had a much larger distribution than I have today. I don't know who read and took heed back then but I wish more had. with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.

From the Declaration of Independence July 4th, 1776

Benjamin Rush was one of the 56 who signed. It is necessary for all of us to appreciate the great risk the signers took and how this once great nation would not have existed if these men did not have courage. I say once great nation because we have not heeded the many warnings of the founding fathers and we have not understood the nature of man as the founders did.

The fact that we have not heeded the Founder's warnings is no accident. The Founders knew that education was the key, unfortunately so did the enemies of liberty and justice. Benjamin Rush knew as did all the Founders that without people being educated in the principles of freedom it could not survive:

“Freedom can exist only in the society of knowledge. Without learning, men are incapable of knowing their rights.”

This compromise of our education system has gone on for so long that few have any knowledge of the principles of liberty. In short we have lost the battle in the class room. Because of our collective ignorance we have lost the foundation, the Constitution. If you do not understand the principles behind the Constitution you cannot defend it.

To illustrate the dimension of the problem please note how our decline of knowledge and understanding was perceived as far back as 1964 in a publication “WE THE STATES” by the Virginia Commission on Constitutional Government:

Today it is apparent to even the most casual eye that the house of our fathers has fallen into decay. The great beams that gave it strength—the separation of powers within the central government, the division of responsibility between the States and the

Federal authority—now tend to crumble under subtle and insidious attack. The men who framed our Constitution built tight doors against the despotism they knew so well; now the doors hang awry, and a cold wind of judicial construction sweeps along the corridors. The States themselves, falling into impotence, often seem helpless to halt the destruction. **And too many Americans, afflicted with the ills of an affluent society, are indifferent to the fundamental principles by which the greatness of the American Republic was achieved.** (emphasis added)

This quote from the publication “We the States” succinctly sums up a condition of decline that was evident as far back as 1964 and has not improved to this day.

W. Cleon Skousen the creator of the great “Miracle of America” course and author of “The 5000 Year Leap—The 28 Great Ideas That Changed the World” started his listing of the principles with these three:

1. The only reliable basis for sound government and just human relations is Natural Law.
2. A free people cannot survive under a republican constitution unless they remain virtuous and morally strong.
3. The most promising method of securing a virtuous and morally stable people is to elect virtuous leaders.

Well, whether we are virtuous as individuals or not we have consistently allowed those that lack virtue to lead us. Our governmental officials over time have consistently bowed to the banks and mega corporations. We as citizens have allowed the erosion of our liberty which has only emboldened the country's leadership. Government over time being drunk with power no longer considers the Constitution when reviewing bills before Congress because they know that the citizens will not vigilantly guard their liberties guaranteed by the Constitution. The banks now run everything and this recent “Wall Street Bailout Bill” will further concentrate there

power. With this “Bailout” the central banks and the government get to decide which businesses succeed and which fail. All of these recipients of the citizen’s largesse have a “One World Government” bent with no concern for us. Thomas Jefferson warned us long ago about the banks:

I believe that banking institutions are more dangerous to our liberties than standing armies. Already they have raised up a moneyed aristocracy that has set the Government at defiance. The issuing power should be taken from the banks and restored to the people to whom it properly belongs.

At what point do we recognize our loss? Here is a short list of our losses to the Bill of Rights:

- 1st Amendment
 - Religion – Prohibiting of prayer in schools and religiously oriented clubs.
 - Freedom of speech – Free speech zones at events, laws against hate speech and restricting political speech before an election.
 - Peaceably assemble – In most cases we need to get official permission in order to peaceably assemble.
 - Petition Government – Recent court decisions have said you can petition all you want but government does not have to answer.
- 2nd Amendment
 - Militias - They have been declared terrorist organizations.
 - Right to Bear Arms – Armed zones (the many areas where we can not carry), registration of weapons carriers and restriction in moving from state to state.
- 3rd Amendment – I know of no abridgement of this amendment but if anyone does please let me know.
- 4th Amendment – Under the Homeland Security Acts this amendment has been pretty well eviscerated.
- 5th Amendment
 - Held without a Grand Jury – Here too the Homeland Security Act has pretty well wiped that requirement out.

- Double jeopardy – there have been instances especially in the hate crime area where the Federal government has stepped in and retried cases.
- Compelled to witness against ones self – well the Homeland Security Act has condoned torture in some instances, so although I cannot name an instance, there may have been some.
- Deprived of life, liberty or property without due process – Many an individual’s property have been seized before trial for crimes as low level as soliciting prostitution (not that I condone that act) before a trial has taken place. Liberty has also been taken under that now infamous Homeland Security Act. The life part I am not sure of.

- 6th Amendment – Although some of these have been abridged under you guessed it the Homeland Security Act, I cannot point to specific instances at this time.
- 7th Amendment – Trial by Jury – I know of no violation of this at present.
- 8th Amendment – Cruel and Unusual Punishment – Well again this time by initials it is the HSA that is the culprit.
- 9th Amendment – The enumeration on the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people – Well do they allow us any rights?
- 10th Amendment – With Federal intervention in every aspect of our lives, I think this amendment is no longer in effect.

So at what point do we recognize our losses? How many bills that have been signed into law since the inception of our Constitution have violated it? I am quite sure the number would be staggering.



Florida has 42 counties, three cities and one town have adopted Second Amendment Sanctuary (or other pro-Second Amendment) resolutions by the most recent information I could find. Currently Palm Beach County is not among the adopters of any 2 A Sanctuary resolutions and the prospects are that they never will adopt any.

So, our only hope is to have a declaration made on the State level. There were several bills put forward this past Legislative session but none of them made their way out of committee. These bills will be reintroduced in the next session and we will have to be vigilant and apply all the pressure we can muster to have these laws adopted.

Appellate court order is a win for gun owners, a loss for Nikki Fried

NICS entry alone NOT sufficient to deny carry license

An [order](#) issued today by Florida’s First District Court of Appeal is a massive win for gun owners, and a huge loss for Agriculture Secretary Nikki Fried, who oversees the Division of Licensing, which is responsible for operating Florida’s concealed weapons licensing program.

The case involves a plaintiff known only as “R.C.” who applied for a Florida concealed weapon license, was rejected and subsequently sued the Department of Agriculture.

“This is the first time we’ve had a judicial opinion in Florida stating that the burden of proof in on the Agriculture Department to prove that someone is ineligible for a concealed weapons license,” said Eric Friday, the attorney who handled the case along with co-counsel Noel Flasterstein.

David Chipman’s nomination to head the ATF resulted in a deadlock 11-11 vote in the Senate Judiciary Committee Thursday.




